American Health Packaging, Inc. is initiating a voluntary drug recall to the **RETAIL LEVEL** for **AHP Bupropion Hydrochloride Extended-Release Tablets USP (XL), 150 mg, 100 UD; Carton NDC#: 60687-782-01, (Individual Dose NDC: 60687-782-11)**, for the lot listed below:

REASON	This recall is being initiated due to an out of specifications for dissolution at the initial stability time point. The product is dissolving faster than specified limits which could lead to a change in therapeutic efficacy.			
HEALTH HAZARD EVALUATION	Bupropion hydrochloride extended-release tablets (XL) are indicated for the treatment of major depressive disorder (MDD), as defined by the Diagnostic and Statistical Manual (DSM). Bupropion hydrochloride extended-release tablets (XL) are indicated for the prevention of seasonal major depressive episodes in patients with a diagnosis of seasonal affective disorder (SAD).
